MEMORANDUM** 2 William E. Scott appeals his 180-month sentence imposed under the Sentencing Guidelines following a jury conviction for bank robbery in violation of 18 U.S.C. Sec. 2113(a). We have jurisdiction under 28 U.S.C. Sec. 1291, and affirm. 3 *

Scott's Guidelines sentence is the mandatory minimum of 360 months. Scott's base offense level was 20. However, the district court correctly reduced his offense level to 17 because he accepted responsibility for the crime. The court calculated an adjusted offense level of 16, added two points because the crime was committed while on probation, and subtracted one point because Scott accepted responsibility. Scott, however, was a career offender

under Guidelines Sec. 4B1.1(B) because he had two prior robbery convictions, and therefore a criminal history category of VI was correct. 4 Section 4A1.3 states that a downward departure may be granted if "the court concludes that the criminal history category... does not adequately reflect the seriousness of the defendant's past criminal conduct or the likelihood that the defendant will commit other crimes." The Guidelines instruct the sentencing court to sentence according to the minimum of either the guidelines range or the mandatory minimum, "but not both." Guidelines Sec
